INTRODUCTION

The International Art Competition "DIFFERENT LOOK" aims to confront various forms of artistic expression of children and adolescents aged 6 to 19. It is aimed primarily at schools and educational institutions, but its open character also allows to an individual participation.

The international nature of the competition provides an opportunity to compare different cultural contexts, exchange experiences and integrate children and young people from different countries. The subject of the competition is a starting point for reflection on the values that relate directly or indirectly to the problems bothering contemporary people.

Every year, the competition works can be carried out in areas corresponding to modern means of artistic expression.

MAIN TOPIC:

Dear participants of the Competition!

Please, put on paper your sensitivity and imagination and show your DIFFERENT LOOK towards the beauty of the world around you – the real world or the world of your imagination. The most important thing is that this world should be full of unusual, amazing places, heroes and adventures.

COMPETITION OBJECTIVES:

- promoting the talent of young children and youth
- encouraging young people from different backgrounds and cultures to reflect creatively on the surrounding world and to dialogue about common values
- searching for new forms and means of artistic expression,

- supporting the creative attitudes of children and youth.
- shaping empathic and pro-social attitudes of participants by donating works sent to the Organizer for a charity purpose.

AGE:

Children and adolescents aged 6-19.

The works will be assessed in the following age categories: 6 - 9 years old, 10 - 13 years old, 14 - 16 years old, 17 - 19 years old.

FORMAT:

A4 (210mm x 297mm), A3 (297mm x 420mm)

Works exceeding the A3 format will not be judged by the jury.

TECHNIQUE:

Any - drawing, painting, collage, graphics,

* Attention! Works made of plasticine and loose materials will not be taken into account. Works sent by e-mail will not be evaluated in the competition.

WORKS EVALUATION and AWARDS:

The jury will award:

- Grand Prix (the laureate will receive: a medal, a commemorative engraved diploma),
- 10 equal prizes in each age category (the winners will receive: a medal, a diploma),
- 10 equal distinctions (the winners will receive a diploma).

People who will honor us with their presence at the closing ceremony of the Competition will additionally receive material prizes obtained from sponsors (e.g. gadgets, books, art supplies, etc.)

DATES:

- accepting competition entries: until 8th January 2024,
- publication of the results of the Competition on the website of the institution: www.opp1.sosnowiec.ehost.pl by 29th March 2024 and on the Facebook page of the Competition
- the closing ceremony of the Competition -10^{th} May 2024.
- Sending awards and diplomas by the end of May 2024.

RULES OF PARTICIPATION:

- works sent to the competition should be the result of independent creative work of the competition participants;
- works cannot take part in other competitions;
- collective works will not be judged in the competition;
- one teacher may submit a maximum of 10 works of his students; The teacher, by placing his signature on the application form, confirms that the student has performed the work independently.
- <u>an application card permanently attached</u> to the back of work, along <u>with a declaration of</u> a parent / guardian or an adult participant
- Works without approvals / declarations will be rejected!
- Please do not bend, roll or frame the submitted works!
- the awarded and distinguished works selected by the Organizer will be published on the website of the competition: www.opp1.sosnowiec.ehost.pl and / or on the Facebook of the competition

FINAL PROVISIONS:

- Participation in the competition is free. The condition for taking part in the Competition is the acceptance of these regulations. The jury reserves the right to make the final interpretation of the Regulations.
- All submitted works, including those awarded and distinguished, become the property of the Organizer, who has the right to use them free of charge in the fields of use chosen by him to an unlimited extent.
- The competition participant or his legal guardian, by placing his signature on the application form, declares that:
- o has full copyrights to the work and transfers them to the Organizer to the extent necessary for its publication and / or other distribution, with particular emphasis on the need to adapt the work to the requirements that must be met when publishing it in electronic or printed version.
- o transfers the proprietary copyrights to the Organizers free of charge without any time and territorial limitations.

- The organizer reserves the right to publish and reproduce the competition works without paying royalties and to present and publish the competition works free of charge in the press, television, on websites and in printed and electronic information and promotional publications of the institution (in whole or in part)

3. PURPOSES AND LEGAL BASIS FOR PROCESSING

The legal basis for data processing are:

- a) Art. 6 sec. 1 lit. a, b, c, e Regulations of the European Parliament and of the Council (EU) 2016/679 of 27 April 2016. on the protection of individuals with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46 / EC (general regulation on data protection) of 27 April 2016,
- b) the Act of May 10, 2018. on the protection of personal data (i.e. Journal of Laws of 2019, item 1781),
- to organize, conduct and promote the 22^{nd} International Art Competition "Different Look" as well as the activities of Ognisko Pracy Pozaszkolnej nr 1 in Sosnowiec

4. DATA RECIPIENTS

The recipients of your child's personal data will only be entities authorized to obtain personal data on the basis of legal provisions.

5. DATA STORAGE PERIOD

Ognisko Pracy Pozaszkolnej nr 1 in Sosnowiec stores personal data for the period necessary to achieve the purpose for which they were collected, but no longer than for the period provided for by law (including the Act of July 14, 1983 on the national archival resource and archives, i.e. Journal of Laws of 2020, item 164, as amended)

6. RIGHTS OF PERSONS WHOSE DATA ARE PROCESSED

You have the right to:

- a) access to your data
- b) rectify (correct) your data
- c) deletion of data
- d) restriction of data processing,
- e) withdraw consent to data processing at any time (withdrawal of consent does not affect the lawfulness of data processing based on consent granted before its withdrawal).

Providing personal data is voluntary, but it is a necessary condition to participate in the competition.

7. PROCESSING OF PERSONAL DATA IN AN AUTOMATED MANNER
